**ANNEXURE (DEFINITION OF “LOCAL AREA” AND “NON LOCAL AREA”):**

**DEFINITION OF “LOCAL AREA” TO TELANGANA STATE/ANDHRA PRADESH:**

**1.**

**i. “AU” Local area comprises of the districts in Andhra Region:**

**ii.** If the candidate has studied 2 years of Intermediate course , X and IX classes / XII, XI, X and IX classes in any of the districts of Andhra Region he/she shall be considered as a candidate belonging to “AU” local area.

**2.**

**i. “OU” local area comprises of the districts in Telangana region.**

**ii.** If the candidate has studied 2 years of Intermediate course , X and IX classes / XII, XI, X and IX classes in any of the districts of Telangana Region he/she shall be considered as a candidate belonging to “OU” local area.

**3.**

**i. “SVU” local area comprises of the districts in Rayalaseema region.**

**ii.** If the candidate has studied 2 years of Intermediate course , X and IX classes / XII, XI, X and IX classes in any of the districts of Rayalaseema Region he/she shall be considered as a candidate belonging to “SVU” local area.

**4.** If a candidate has not studied the preceding 4 years of the Qualifying examination (Intermediate II year down to IX or XII class down to IX) in one local area(AU/OU/SVU) but studied in different local areas then the maximum period of his/ her study preceding 7 years of the qualifying examination (Inter second year down to VI class or XII down to VI class) shall be taken into consideration to decide his/ her local area. The preceding 7 years of study before appearing for the qualifying examination should be in the state of Telangana State/ Andhra Pradesh only.

Ex.1 (Study period):

- (a) Inter II year in AU local area
- (b) Inter 1<sup>st</sup> year and X in “OU” local area.
- (c) IX and VIII in “SVU” local area.
- (d) VII and VI in “AU” local area.

Then the candidate belongs to **“AU” Local area.**

Ex.2 (Study period):

- (a) Inter II year and I years in “OU” local area
- (b) X and IX in “SVU” local area.
- (c) VIII in “OU” local area.
- (d) VII in “SVU” local area.
- (e) VI in “AU” local area.

Then the candidate belongs to **“OU” Local area.** Since he/she has studied the preceding 2 years of qualifying examination (Intermediate) first in “OU” local area though the periods of study in “OU” and “SVU” local areas are equal (i.e.) 3 years in each local area.

If a candidate has not studied in any recognized / unrecognized school (from Inter II year down to VI class) and appeared for VII, X and Intermediate Government Examination directly then the period of

his/her residence will be taken into consideration to decide the local area, in all such cases the residence certificate issued by the MRO/s of the local area/s where the candidate has actually resided during the period from VI to Intermediate clearly specifying place, Mandal, District period of residence etc., should be produced by the candidate at the time of admission, to decide about local status.

**DEFINITION OF “NON LOCAL AREA” TO TELANGANA STATE/ANDHRA PRADESH:**

- (i) If a candidate has studied outside Telangana State/ Andhra Pradesh, a part of the preceding four years of the qualifying examination i.e. from II year Intermediate down to IX Class, he/she shall be considered as **“Non-Local”** candidate to Telangana State / Andhra Pradesh.
- (ii) If a candidate has studied the preceding 4 years of the Qualifying examination (Intermediate II year down to IX) in different local areas of Telangana State / Andhra Pradesh and a part of the remaining three years of study (from VIII down to VI) outside Telangana State / Andhra Pradesh he/she shall be considered as a **“Non-Local”** candidate to Telangana State / Andhra Pradesh.

**Note:-** In the above two cases (i) and (ii) the candidate shall be considered as a **Non-Local”** to Telangana State / Andhra Pradesh provided either of his / her parents have resided in Telangana State / Andhra Pradesh for a period of 10 years excluding the period of their employment outside Telangana State / Andhra Pradesh or the candidate himself/herself has resided in Telangana State / Andhra Pradesh for a period of 10 years excluding the period of his/her study outside Telangana State / Andhra Pradesh. A residence certificate for a period of 10 years in Telangana State / Andhra Pradesh (giving the details of the place, Mandal, District, etc.) is to be produced by the candidate from MRO to consider him/her as **“Non-Local”** for admission. Otherwise the candidate need not be considered for admission.

- (iii) A candidate who is **“Non-Local”** to Telangana State / Andhra Pradesh by virtue of his/her studies outside Telangana State / Andhra Pradesh and whose parent (Father/Mother) is working at present in any State/Central Government office or their undertaking or Quasi Government organization in Telangana State / Andhra Pradesh need not produce 10 years Residence Certificate of Telangana State / Andhra Pradesh. However, the candidate has to produce the Service Certificate of his/her Parent from the concerned organization as a proof to consider him/her as a **“Non-Local”** candidate for admission.
- (iv) A candidate who is **“Non-Local”** to Telangana State / Andhra Pradesh by virtue of his/her studies and whose spouse is working at present in any State/Central Government office or their undertaking or Quasi Government organization need not produce 10 years Residence Certificate of Telangana State / Andhra Pradesh. However, the candidate has to produce the Service Certificate of his/her spouse from the concerned organization as a proof to consider him/her as a **“Non-Local”** candidate for admission.

**Note:- A CANDIDATE WHO DOES NOT SATISFY ANY OF THE ABOVE MENTIONED CONDITIONS, CANNOT BE CONSIDERED FOR ADMISSION.**
