

INSTRUCTIONS TO THE CANDIDATES

The candidates seeking Admissions in B.Arch, before applying, please read the below NOTE carefully:

NOTE:

- 1) Candidates writing NATA-2021 3rd Test (To be held on 03.09.2021) are required to register and upload their Certificates only after declaration of 3rd NATA-2021 Test Results
- 2) Candidates writing JEE (Main)-2021 B.Arch. (Paper-2A) Session 4 to be held from 26th August, 2021 to 2nd September, 2021 are required to register and upload their Certificates only after declaration of Session 4 JEE Test Results.
- 3) Any false or incorrect information furnished detected at any stage will render the admission of the candidate null and void.
- 4) The Convener reserves the right to cancel the admission of the candidates at any stage if/when it is detected that admission is against the rules.

D) Eligibility Criteria for Admission:

The eligibility criteria for Admission into Under Graduate 5-year B. Arch. course shall be as mentioned below;

- i. The candidate should be of Indian Nationality.
- ii. The candidate should satisfy 'local'/'non-local' status requirements as laid down in the A.P. Educational Institutions (Regulation of Admission) Order, 1974, as subsequently amended.
- iii. No candidate shall be admitted to B.Arch course unless she/he has passed an examination at the end of the 10+2 scheme of examination with Physics, Chemistry & Mathematics subjects or passed 10+3 Diploma Examination with Mathematics as compulsory subject as the case may be.
- iv. All candidates need to qualify an Aptitude Test (NATA) conducted by the Council of Architecture for admission to B.Arch course. Therefore, all candidates who have passed in any other aptitude test in Architecture conducted by other authorities shall also be required to qualify NATA in order to be eligible for admission to the B.Arch course.

NOTE: For candidates who appeared in both NATA and JEE (Main) B.Arch.Paper-2A Examination, State Architecture Rank (SAR) shall be prepared on the basis of higher percentage of the two scores.

II) Registration cum Processing Fee:

All candidates are informed to register online at <http://barchadm.tsche.ac.in> from 4th September, 2021 to 16th September, 2021 and furnish all information in the application form. All the entries should be correct and the candidate is responsible

for any incorrect entry. All the candidates have to pay Rs. 1,500.00 (Rupees: One thousand five hundred only) each towards Registration cum Counseling Fee and in case of SC/ST Candidates Rs. 800.00 (Rupees: Eight hundred only) and has to be paid through **online** through Payment Gateway only (Credit Cards/Debit Cards/Internet Banking) in favour of '**Secretary, TSCHE**'.

NOTE: The Registration fee once paid will not be refunded.

IV) Certificates to be uploaded at the time of Registration and filling application form

The NATA qualified, eligible candidates only have to scan and upload the following original certificates for verification and submit a Self declaration form given in Annexure.

- **NATA Hall Ticket / Application Number (Mandatory).**
- **NATA Valid Score Card (2021) (Mandatory).**
- **JEE (Main) Paper -2 (B.Arch.) Hall Ticket/Application Number and valid score card of 2021 (Mandatory),** in case JEE score is required to be considered for State Architecture Rank (SAR)
- Aadhaar Card.
- Provisional (Intermediate/Diploma) Certificate.
- Memorandum of Marks of Intermediate or Equivalent/Diploma.
- SSC Pass Memo or its Equivalent for proof of Date of Birth.
- **Caste Certificate** issued by competent authority, if applicable.
- **Income Certificate** issued on or after 01.01.2021 (if applicable) by the Competent Authority, if applicable.
- **Economically Weaker Sections (EWS) Reservation:**

**As per the Guidelines issued in G.O.Ms.No.244, General Administration (SER.D) Department, Government of Telangana, dated. 24.08.2021, the 10% Reservation to the Economically Weaker Sections (EWS) in respect of*

Admissions into Educational Institutions shall be implemented subject to grant of permission by Council of Architecture. The benefit of reservation under EWS can be availed upon production of an Income Certificate issued by Tahsildar valid for the year 2021-22.

- Transfer Certificate (T.C.) (Mandatory).
- Migration Certificate if required.
- *The Muslim and Christian Minority Candidates should upload the "TC" of the SSC containing Minority status (or) in the absence of TC, a Certificate issued by the Head of the Institution in which the student studied/appeared for SSC or its equivalent examination.*
- **Study Certificate** from VI to XII/ Diploma (To establish local area of the candidate) in case of candidate with institutionalized education.
- **Residence Certificate** of candidate for a period of 7 years preceding to qualifying examination in case where the candidate has no institutionalized education.
- In respect of **Non-Local** candidates in order to consider them for allotment under unreserved seats the following certificates needs to be submitted.
 - **Residence Certificate:** Candidate who has resided in the State for a total period of 10 years excluding periods of study outside the State; or either of whose parents have resided in the State for a total period of 10 years excluding periods of employment outside the State.

(OR)

- **Employer Certificate:** Candidates who are children of parents who are in the employment of this State or Central Government, Public Sector Corporations, Local bodies, Universities and other similar Quasi Public Institutions within the State at the time of applying for NATA/ JEE (Main) Paper -2 (B.Arch.) examination.
- **Candidates who studied Intermediate or Equivalent/ Diploma in Engineering in other States in India or from other Countries should upload Equivalency Certificate issued by the Board of Intermediate Education, Telangana State (Mandatory).**

SPECIAL CATEGORY: Certificates to be uploaded by PH/ CAP/ NCC/ Sports (SG) candidates along with Application:

- **PH-Certificate** issued by District Medical Board. Candidates with 40% and above disability are only eligible.
- **CAP (Children of Armed Forces Personnel):** Candidates whose parents are domiciled in the State of Telangana based on the permanent address/home town declared by

them while joining the service and as recorded in their Service Register are alone eligible to be considered under "CAP" Category.

- a) "(2) Children of Armed Forces (CAP) 2% (two percent) for the children of armed persons i.e., Ex-Servicemen, Defence Personnel including the Children of Border Security Force and Central Reserve Police Force who are Domiciled in Telangana State based on the Permanent address/ Home town declared by them while joining the service and as recorded in their Service Register".
 - b) The Ex-Servicemen have to produce the Children of Armed Forces Personnel (CAP) certificate issued by respective Regional Sainik Welfare Officer as per Appendix-"A" Attached with supporting documents to establish the Permanent address/ Home town declared by Ex-Servicemen while joining the service and as recorded in their Service Register in accordance with Go, such as Certificate from Records Office, Education Certificates of Ex-Servicemen, etc.
 - c) Serving Defense Personnel including CRPF and BSF Personnel should submit a Children of Armed Forces Personnel (CAP) certificate issued by unit Commanding officer (not less than the rank of a Colonel/ equivalent in Navy and Air Force Commandant in CRPF/BSF) as per Appendix- "B" Attached alongwith original and attested copy of Service Register where the Permanent address/ Home town declared by them while joining the service is mentioned along with the education certificates of the Serving Defence personnel.
 - d) The retired CRPF and BSF Personnel have to produce the Children of Armed Forces Personnel (CAP) certificate issued by their respective competent authority as per Appendix-A along with supporting documents to establish the Permanent address/ Home town declared by them while joining the service and as recorded in their Service Register in accordance with GO, such as Certificate from Records Office, Education Certificates of CRPF/BSF personnel, etc.
- NCC - Certificates issued by competent authorities.
 - **Sports (SG)** - Sports Achievements / Testimonials along with the Form- I, II, III & IV duly certified / attested by the Concerned State Sports Associations recognized by the SATS which are categorized according to level of the Championships as laid down in G.O.Ms.No. 02, Youth Advancement, Tourism & Culture (Sports) Department, dated: 22-09-2020, which are essential during Scrutiny.

1. **All original certificates to be scanned and uploaded.**
2. **If required candidate seeking admission under special categories have to appear in person for verification before the relevant competent authority.**

VI) Certificate verification and counseling:

- In view of pandemic and JNAFAU being in schedule-X, the certificate verification will be done based on scanned copies of original documents uploaded and as per norms.
- In case of any doubt, enquiry will be done over phone to establish the veracity and correctness of documents.
- Procedure for exercising options will be made available on the website i.e. <http://barchadm.tsche.ac.in> well before the commencement of the option entry.
- List of Provisionally selected candidates will be prepared College wise and will be placed in the website i.e. <http://barchadm.tsche.ac.in> and SMS will be sent to the valid mobile number furnished in the application.
- **Tuition fee has to be paid online through Payment Gateway only. Please keep sufficient balance in your Bank Account /Card to pay immediately.**
- Final allotment of seat for admission is subject to satisfactory verification of all original certificates at reported college and producing fee receipt.
- Candidates have to report to the concerned college and produce all original certificates within the stipulated time.
- **Allotment order will be printed at the college and also joining report, which has to be submitted at the college along with original T.C.**
- **Candidates have to submit two sets of attested copies of all certificates at the respective colleges, one set is meant for submission to the office of the Convener. After final phase, the T.C. has to be submitted at the time of payment of College fee.**
- If the candidate cancels his/her admission, tuition fee will be forfeited as mentioned below:
 - **After first phase, full tuition fee will be refunded.**
 - **50% of the tuition fee will be forfeited after final phase and before cutoff date notified for cancellation in allotment order and 100% thereafter.**

VII) Rules of Reservation for admission.

Admissions will be made as per rules of reservations in vogue at the time of Counseling.

- i) The seats in SPA, JNAFAU which is a Statewide Institution shall be filled as per the Presidential order. In other words admission into 85% of seats shall be reserved for the candidates belonging to three local areas AU, OU, SVU in the ratio 42:36:22 and the remaining 15 % seats shall be Unreserved.
- ii) In the affiliated Colleges of Telangana State, admission to 85% of the Convener Quota seats shall be reserved for the local candidates of Telangana State and the remaining 15% shall be Un-reserved seats.

- iii) Cent-percent (100%) of seats in University College and 70% of the sanctioned intake of seats in unaided (affiliated), non minority and minority professional institutions will be filled by the Convener Architecture Admissions - 2021.

The Principals are directed to fill up the management quota of seats in their respective colleges by issuing a separate notification in the leading daily Newspapers and following TSCHE guidelines. Candidates should be admitted as per admission rules in vogue. The details of the seats filled under “**Management Quota**” shall be communicated to the “Telangana State Council of Higher Education (TSCHE)” for necessary approval and ratification.
